# **Fundraisers Update - Diandre Langlais**

- We did 19 For Profit events and 5 Nonprofit events
- Total revenue was \$27,551.75, Munchalunch/Stripe fees were \$1,492.17 which made up 5.42% of the revenue
- 424 families out of 600 used it and about 1/3 of the school placed orders on each event
- We were able to run more events, more efficiently by using Munch if PAC uses School Cash Online, the district absorbs the cost but we shouldn't be using district funds for PAC
- Diandre has made notes on all vendors and foods only one had cold food
